

1. *Approval of Payments/Warrants

Construction Warrant Number 004182 -004192 \$ 2,367,177.80 Operational Warrant Numbers 132203 - 132525 \$ 2,762,597.08

- 2. *Award Construction Contract for Perimeter Road Paving Shamrock Paving, Inc. The Engineering Committee and staff recommend award of a construction contract to Shamrock Paving, Inc. in the amount of \$163,073.94 including Washington state sales tax for perimeter road paving. Paving the access road at gate H and a utility trench patch at the Air Cargo Facility are also included. The Engineering Committee and staff further request Board authorization of \$16,300.00 for construction contingencies, for a total authorization of \$179,373.94 including Washington state sales tax.
- 3. *Approve Amendment to Board Authorization of Expenditures for Elevator and Escalator Maintenance Services Contract *Kone, Inc.* The Engineering Committee and staff recommend approval of a \$25,000 increase to the Elevator and Escalator Maintenance Services Contract with Kone, Inc. for a total authorization of \$325,000, including Washington state sales tax for the remaining three-year term ending September 30, 2016.
- 4. *Approve Fourth Amendment to Snow Removal Services Contract Haase Landscape, Inc. This amendment exercises the last of four options with Haase Landscape to provide on-call snow removal services in the Airport Business Park. The term of the contract shall commence November 1, 2016 and the rates per hour will remain unchanged from 2015. The Finance Committee and staff recommend approval.
