*Approve Amendment No. 3 to Professional Services Agreement – Professional Architectural and Engineering Services for Bulk Hangar – *JRMA* – Felts Field. In February 2017, Spokane International Airport solicited statements of qualifications from qualified Architect/Engineer (A/E) firms for the Felts Field Bulk Hangar project, selecting J.R. Miller & Associates (JRMA). During design development, the prospective tenant requested a change in the design to incorporate pre-cast concrete panels into the structure. JRMA has provided a fee proposal for Amendment No. 3 in the amount of \$17,740.00. The Engineering Committee and Staff recommend approval of Amendment No. 3 in the amount of \$17,740.00 to the Professional Services Agreement with JRMA for the Bulk Hangar project. The revised contract amount is \$523,720.00.

- *Approve Reimbursable Agreement Runway 7-25 Magnetic Variation Change and 3. Lisa **Taxiway C Shoulder Improvements Project** – Federal Aviation Administration – Spokane SIA International Airport. Under the Runway 7-25 Magnetic Variation Change and Taxiway C Shoulder Improvements Project, the Runway End Indicator Lights (REIL) will be relocated with the widening of the taxiway shoulders per the newer FAA Advisory Circular guidelines. The Reimbursable Agreement (RA) will allow the FAA to procure design, construction, and commissioning services for the new facility. This project is a Federally-funded project under the Airport Improvement Program (AIP) and therefore the RA will be eligible for 90% reimbursement under the upcoming 2018 AIP grant. Following review of the RA, the FAA estimated a total cost of \$261,167.26 for design, construction, and commissioning of the REILs. The Engineering Committee and Staff recommend approval of the FAA Reimbursable Agreement, contingent upon receipt of the FAA AIP Grant, for improvements to the REILs under the Runway 7-25 Magnetic Variation Change and Taxiway C Shoulder Improvements Project in the amount of \$261,167.26.
- 4. * Award Construction Contract – Gas Station and Convenience Store Site Preparation and Lisa Access Road Improvements (Phase 2) – Piersol Construction, Inc. – Spokane International SIA Airport. The second phase of this project will include the extension of a water main; construction of a connector road from Inbound to Outbound of Airport Drive; construction of acceleration and deceleration lanes on both Inbound and Outbound Airport Drive; installation of roadway lighting and signage; and landscaping and irrigation improvements. Also included are additive alternates for a temporary paved overflow parking area on the site, connecting to the existing economy parking lot. Bid Documents were prepared by J-U-B Engineers, Inc. and the project was publically advertised. After a mandatory Pre-Bid Meeting, followed by bid opening, three bids were received. The lowest responsive and responsible bid was submitted by Piersol Construction, Inc. in the Base Bid amount of \$1,700,978.87 and \$1,969,939.16 including the Additive Alternates. The Engineering Committee and Staff recommend award of a Construction Contract for the Gas Station and Convenience Store Site Preparation and Access Road Improvements (Phase 2) to Piersol Construction, Inc. for the Base Bid Schedules only in the total amount of \$1,700,978.87, including Washington State Sales Tax. The Engineering Committee and Staff further request Board authorization of \$170,000.00 for construction contingencies for a total authorization of \$1,870,978.87.
- 5. * Award Service Contract Spent Aircraft Deicing Fluid (ADF) Recovery Maintenance Ryan Services Inland Technologies International, Ltd. Spokane International Airport. In 2015, the Board awarded a contract to Inland Technologies International, Ltd. to provide aircraft deicing fluid recovery services to the Airport. That contract and all awarded options expire on April 30, 2018. The Airport developed a comprehensive scope of work and after preparation of documents by the Airport Staff and public advertisement, one bid was received on March 23, 2018 from Inland Technologies International, Ltd. in the amount of \$299,700.00 including Washington State Sales Tax. The previous contract was \$295,000.00, representing a 1.6% increase in annual cost. The Engineering Committee and Staff recommend award of a Service Contract for Spent Aircraft Deicing Fluid (ADF) Recovery Maintenance Services to Inland Technologies International, Ltd. in the amount of \$299,700.00 including Washington State Sales Tax. Staff further requests Board authorization of \$30,000.00 for contract contingencies for a total authorization of \$329,700.00.
- 6. *Award Construction Contract for the Center Stairwell Rehabilitation Project East Parking Garage Wm. Winkler Co. Spokane International Airport. This Project consists of rehabilitation to the center stairwell of the East Parking Garage (floors 3-5) and includes removing and disposing the existing in-filled concrete and steel stair-nosing; in-filling the entire recessed portion with high strength concrete; and furnishing and installing an anti-slip metal nosing. The project was bid through the Small Works Roster and two bids were received. The lowest responsive and responsible bid was submitted by Wm. Winkler Co. in the amount of \$54,112.77. The Engineering Committee and Staff recommend award of a Construction Contract for the Center

Stairwell Rehabilitation Project – East Parking Garage to Wm. Winkler Co. in the amount of \$54,112.77 including Washington State Sales Tax. Staff further requests Board authorization of \$5,000.00 for construction contingencies for a total authorization of \$59,112.77.

- 7. * Award Professional Services Agreement – Consulting Engineering Services for Surface Matt Parking Lot Expansion - T-O Engineers - Spokane International Airport. In February 2018, SIA Spokane International Airport solicited statements of qualifications (SOQ) for this project and after review of the SOQs by the Airport's Selection Team, T-O Engineers was selected as the most qualified firm. The project Scope of Work includes preparation of plans and specifications for the East Surface Parking Lot and wetland mitigation coordination for the 3.5 acre future West Surface Parking Lot. Design services for the East Lot will be completed in the spring of 2018 and construction will occur in the summer and fall of 2018. Preliminary design, final design, bidding, and construction will be completed for the entire East Surface Parking Lot, including approximately 12 acres of additional passenger parking capacity. The preliminary opinion of cost for the East Lot is \$7.2 million. The Scope of Work includes environmental planning, geotechnical investigation, civil and electrical design, traffic and signage design, landscape design, and turnkey construction phase services. The Engineering Committee and Staff recommend award of a Professional Services Agreement to T-O Engineers for engineering design of the surface parking expansion in the amount of \$795,412.00. Staff further recommends Board approval of \$79,000.00 for design contingency for a total authorization of \$874,412.00.
- 8. *Approve Procurement of Shuttle Buses – Schetky Northwest Inc. – Spokane International Andrew Airport. The Airport's Parking Department operates four transit shuttles that provide SIA transportation to and from the Economy Parking Lot and Terminal. Two of the four Shuttles Buses (a 2009 GMC Titan 25' and a 2014 E F450-Ford Super Duty Cutaway) are experiencing significant mechanical problems, have reached the end of their life expectancy, and are due for replacement. Airport Staff researched available equipment options and determined that the Champion LF Transport (Low-Floor) FORD E450 Bus meets the needs of the Airport. The proposed vehicles are available through the Washington State Department of Enterprise Services (WSDES), Purchasing Contract No. 04115, Light to Medium Duty Transit Buses. One of the existing shuttles will be disposed of at auction, and the other will be transferred to the Airport Operations Department for special events and irregular operations responses. The total purchase price for these three vehicles is \$316,381.58, which includes all optional equipment, freight charges, and Washington State Sales Tax. The Engineering Committee and Staff recommend procurement of three Shuttle Buses through the Washington State Department of Enterprise Services, Purchasing Contract No. 04115, in the amount of \$316,381.58 including Washington State Sales Tax. Staff further requests Board authorization of \$25,000.00 for contingencies for a total authorization of \$341.381.58.
