**Spokane International Airport
For-Hire Vehicle Operator
APPLICATION**

Spokane Municipal Code 12.03.0508 provides that no person shall operate any vehicle for hire from the Spokane International Airport ("SIA") unless such operation is with the approval of the Spokane Airport Board and under such terms and conditions as the Airport Board prescribes. Prior to operating any vehicle for hire to and/or from SIA, the Spokane Airport Board requires vehicle owners and/or operators to obtain a For-Hire Vehicle Operating Agreement ("Agreement"). Only agreement holders operating in compliance with SIA will be authorized to drive on SIA property for the purposes of picking up and dropping off airport passengers.

Please review this Application and answer each question clearly and completely. Answers may be typed or printed. When submitting this Application, please include a copy or original of any document requested within the Application. Upon completion of its review, SIA will notify applicants if the Application has been approved. The Applicant shall not commence commercial operations on SIA property until such time as SIA and the Applicant have mutually-executed the Agreement.
