2. Important Items

- a. Retainage Please see the Supplement to General Conditions § 2.04
- b. You will have 45 Days to complete from NTP, we may assess liquidated damages of \$250 per calendar day.
- c. A 5% Bid Bond is required. See bond notes below.
- d. Certificate of insurance requirement is \$5M
- e. This is a Public Works job, prevailing wage is required.

3. NEW LAW

- a. Please notice the Wage Compliance Certification. It is on the checklist and is a requirement.
- 4. Addendums will be issued via email to pre-bid meeting attendees only.
- 5. Are there any questions on the bidding process?

Project Details discussion:

- 1. Security, badging is required. It is not on the airfield however; it is on the airside of the fence.
- 2. Badging can take up to two (2) weeks to get and it does require fingerprinting and 2 hours of training. You can escort up to 5 people but they must stay together.
- 3. API Certificate is required.

- 4. Tanks must be cleaned one at a time. For this reason, the project will be done in three (3) phases. Down time between tanks is approximately one to two days. If the contractor finds there is not enough time, identify reasons and ask.
- 5. Our staff will do the pump down and once complete will be the ones to close everything up.
- 6. The amount of residual fuel is approximately 1,000 at most. Once pumped, maybe a gallon or two. Regardless SIA will pump out as much as possible.
- 7. Hazardous waste disposal of water, documents from cradle to grave is the contractor's responsibility and must be provided to SIA upon completion.
- 8. For identified repairs, contractor is to evaluate and provide a cost estimate and SIA will decide what to do.
- 9. Hours of work are 5am to 4pm but we can accommodate any shift.
