I. INTRODUCTION

This is a mandatory meeting for all prime contractors. Subcontractors are not required to attend the pre-bid meeting. The Airport is bidding this project under their Small Works Roster. All members of the meeting introduced themselves.

II. PROJECT DESCRIPTION

- > Overview
 - The project is located on airport property. The work is contained within the airport terminal & parking lots (APM locations, Economy Lot, C-Concourse, Outside Lot, Garages and Employee Lots).
 - The Contractor must be approved by the manufacturer (SKIDATA Inc.) to provide all labor, supervision, insurance, permits, tools, materials, supplies, training, transportation and equipment needed to perform periodic software support, maintenance and repairs to the Airport's Parking Revenue Control System.

- Project Term/Schedule
 - The term of this contract shall be one (1) year commencing on or around April, 1st 2018 and expiring on March 31, 2019. The Airport shall have the option to renew this Contract for two (2) additional one (1) year term(s), providing that the work performed under this Contract has been fully satisfied by the Airport.

- The bid for Item No. 2 and 3 below rate and percentage will remain firm through the term of the contract.

III. ADMINISTRATIVE

- Prevailing Wages Prevailing wages must be paid on this project. The Contractor must submit intents, certified payroll, affidavits, etc.
- Retainage The Owner shall retain 5% of the total amount of each progress payment for the duration of contract. Or Retainage Bond, this bond is issued for the amount of retainage that would have been withheld on gross cost of the contract. Please refer to the General Conditions.
