The general nature of the Work is as follows:

The Work includes removal of existing full-strength and shoulder pavements associated with utility replacement, removal of taxiway edge lights, centerline lights and signage, removal of underground electrical and drainage, marking obliteration; construction of approximately 33,000 SY of Portland Cement Concrete (PCC) taxiway pavement, new shoulder pavement associated with utility replacement, installation of aggregate base, underdrain and drainage improvements, grading, topsoiling, seeding, new airfield signage and infrastructure, new taxiway edge and centerline lights.

Each bid must be accompanied by a cashier's check or surety bid bond, in an amount of not less than five percent (5%) of the total bid for all bid schedules (including sales tax). A performance bond, payment bond, and liability insurance in accordance with the contract documents will be required for the Contract. This is a prevailing wage project per applicable State Law.

The Spokane Airport Board reserves the right to reject any and all bids, to waive any informality, to accept any alternate bids, and to make such award that it deems to be in the best interest of the Airport pursuant to the terms of the Instruction to Bidders and General Conditions. The contract will be awarded to the lowest responsive and responsible bidder. All bidders are cautioned to be aware of the requirement to have their bids considered responsive.
