Work generally consists of marking removal, and demolition of the existing West Infield Apron, construction of the West Infield Taxilanes, airfield lighting modifications, excavation, subbase course, base course, bituminous pavement, applying pavement markings on the airfield, drainage improvements, water utility modifications, sanitary sewer utility modifications, electrical utility modifications, installation of a prefabricated structure, topsoiling, seeding and other miscellaneous items.
