 - a. Spent ADF Recovery from aircraft parking areas, testing and land application. Purchase and installation of collection tank liner.

 - b. Retainage Five percent (5%) retainage will be withheld until final project closeout. Please see the Supplement to General Conditions § 5.04 for additional information.
 - c. A 5% Bid Security is required in the form of a bond or cashier's check only.
 - d. Certificate of insurance requirement is \$5M

1. Project Overview

- a. 24-7 availability
- b. Land/fluid application dates are very important
- c. Liner: contractor is responsible for install prior to use in the fall.
- d. <u>IMPORTANT</u>: City of Spokane, fire hydrant use requires permit. Contractor cannot use our permit. Contractor will need to verify and include the cost and acquisition of the permit required to use the fire hydrant annually (Jan-Dec) within their bid.

Q&A

Q. Last time we submitted a bid bond to Spokane it stated it was for the sum of "Five Percent of Tender Price". Can we do that again, or do you want the actual amount listed?

A. Yes, you can.

Q. The Spokane International Airport estimates one thousand seven hundred fifty (1750) labor hours for the collection and application of spent ADF. The estimated hours will

not be included in the monthly service amounts. The estimated hours will be a

separate charge billed per hour(s) of labor per month.

Bid tab form says 2000 hours.

A. Contractor is responsible for managing these hours. While additional hours may be necessary due to variability of weather, historically this has remained less than 2000.

8.1. Contractor to supply and install liner system compatible with existing on-site tank:

Modutank MT 1919 71.9' x 71.9' x 6' 221,000-gallon capacity

Q. It is assumed that the existing tank frame is in good condition. Below is what we are assuming is being asked of the contractor please confirm. The urgency is that we need to confirm pricing with the supplier for materials. The bid tab also is requesting the price include installation but does not reference the removal and disposal of the exiting liners and cover. Should the removals and disposal be included as part of the installation?

A. Yes

Q. Clarification on specifications:

45 mil reinforced polypropylene primary liner

45 mil reinforced polypropylene secondary liner

8 oz geotextile liner underlayment

8 oz geotextile leak detection medium between primary and secondary liners

Dip tube leak detectors (qty. 4)

45 mil reinforced polypropylene floating cover Yes

incorporating:

floatation logs Yes

- ballast pipe Yes
- polypropylene rope retention grid

A. Yes, to all the above. While we cannot specify the brand, this does describe what is needed. There is no flexibility on the measurement as the liner must fit the existing fixture that cannot be modified.

Q. We were interested in bidding tank lining on this project and wanted to ask about the plans. I downloaded what was available and did not see any plans or specs specific to the tank lining only a general layout of the collection area?

A. There are no plans for the liner. We suggest reaching out to the manufactures of the product and/or our exiting Modutank frame manufacture as specified within the bid documents. The bidder must find or make a liner that fits, functional and can provide warranty.
