Proposers must certify that they have not imposed any condition on any subconcessionaire, prospective subconcessionaire, local operator, or ACDBE operator that seeks to restrict the ability of such subconcessionaire or operator to participate as a subconcessionaire, franchisor, licensor, or product vendor using the same concept/brand or otherwise, with any other Proposer that may submit a Proposal in response to the Food Service and Retail RFP (#23-49-9999-018) or any other Airport Concession RFP issued by the Board. The following are excluded from this provision:

- Exclusive joint venture partnerships
- Exclusive franchises or licenses with national brands
- Proposer requirement that prospective subconcessionaires, local operators, or ACDBE operators enter into appropriate nondisclosure agreements governing proprietary information provided by Proposer related to this RFP process

# Prohibition on Exclusive Subconcessionaire, Prospective Subconcessionaire, ACDBE Operator, and Local Operator Form

The following form must be executed by authorized representatives of Concessionaire <u>and all of Concessionaire's subconcessionaires</u>, <u>prospective subconcessionaires</u>, <u>ACDBE operators</u>, and <u>local operators</u>. Please complete <u>one form for each</u> subconcessionaire, prospective subconcessionaire, ACDBE operator, and local operator and submit with Proposal.

Concessionaire and all subconcessionaires, prospective subconcessionaires, ACDBE operators, and local operators hereby certify that, as of the Proposal Deadline set forth in this RFP, neither Concessionaire nor any entity comprising Concessionaire is a party to any agreement with, or otherwise imposes any condition on, any subconcessionaire, prospective subconcessionaire, ACDBE operator, or local operator that seeks to restrict the ability of such subconcessionaire or operator to participate as a subconcessionaire, franchisor, licensor, or product vendor, using the same concept/brand or otherwise, with any other Proposer that may submit a Proposal in response to this RFP or any other Airport Concession RFP issued by the Board contemporaneously herewith.

This certification pertains only to exclusive arrangements between Concessionaire and any actual or prospective subconcessionaire(s), ACDBE operator, or local operator. It shall not restrict Concessionaire's right to enter into or maintain exclusive joint venture partnerships, exclusive franchise or licensing arrangements with national brands, nor shall it prohibit Concessionaire from requiring that subconcessionaires, prospective subconcessionaires, ACDBE operators, or local operators enter into appropriate nondisclosure agreements governing proprietary information provided by Concessionaire related to this RFP and the Proposal.

Spokane Airports is jointly owned by Spokane County and the City of Spokane. The city and county operate the airports under provisions of RCW 14.08, which establishes the operation of airports by more than one municipality under joint agreement. The operating authority of Spokane Airports is the Spokane Airport Board, consisting of seven appointees from the two governmental bodies. The Board annually oversees a capital and operating budget of approximately \$118 million from various funding sources.

The Board operates three facilities: Spokane International Airport, Felts Field Airport, and the Airport Business Park, as well as, has a Grant of Authority to operate Foreign-Trade Zone #224. All three facilities are financially self-sufficient from revenues generated from fees, leases and concession agreements. None of the three entities receive, nor are operated with, appropriated tax dollars.

Spokane International Airport is a 6,000-acre commercial service airport served by six airlines and three air cargo carriers. The airport processed nearly 4 million passengers and 78,658 U.S. air cargo tons in 2022. It is the second largest airport in the State of Washington and recognized by the FAA as a small hub. The Airport is an employment for over 3,000 people and has important and expanding transportation, logistics and airfield aerospace industry clusters. The Airport has a \$3 billion direct and indirect economic impact annually on the Spokane Region.



#### **Terminal Area Diagram**








**Unit R-212 Lease Outline Drawing** 















Units R-212, R-214, R-216 Elevations








**Unit R-207 Lease Outline Drawing** 






**Unit R-215 Elevation** 









**Units R-209, R-211, & R-213 Elevations** 













**Unit B-204 Lease Outline Drawing** 

















**Unit C-25 Elevations** 













#### **Unit CC-02-1010 Elevations**


