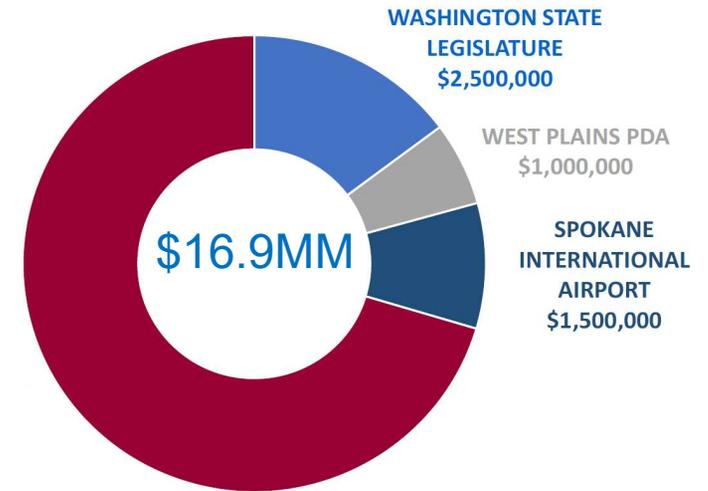

Rail-Truck Transload Benefits

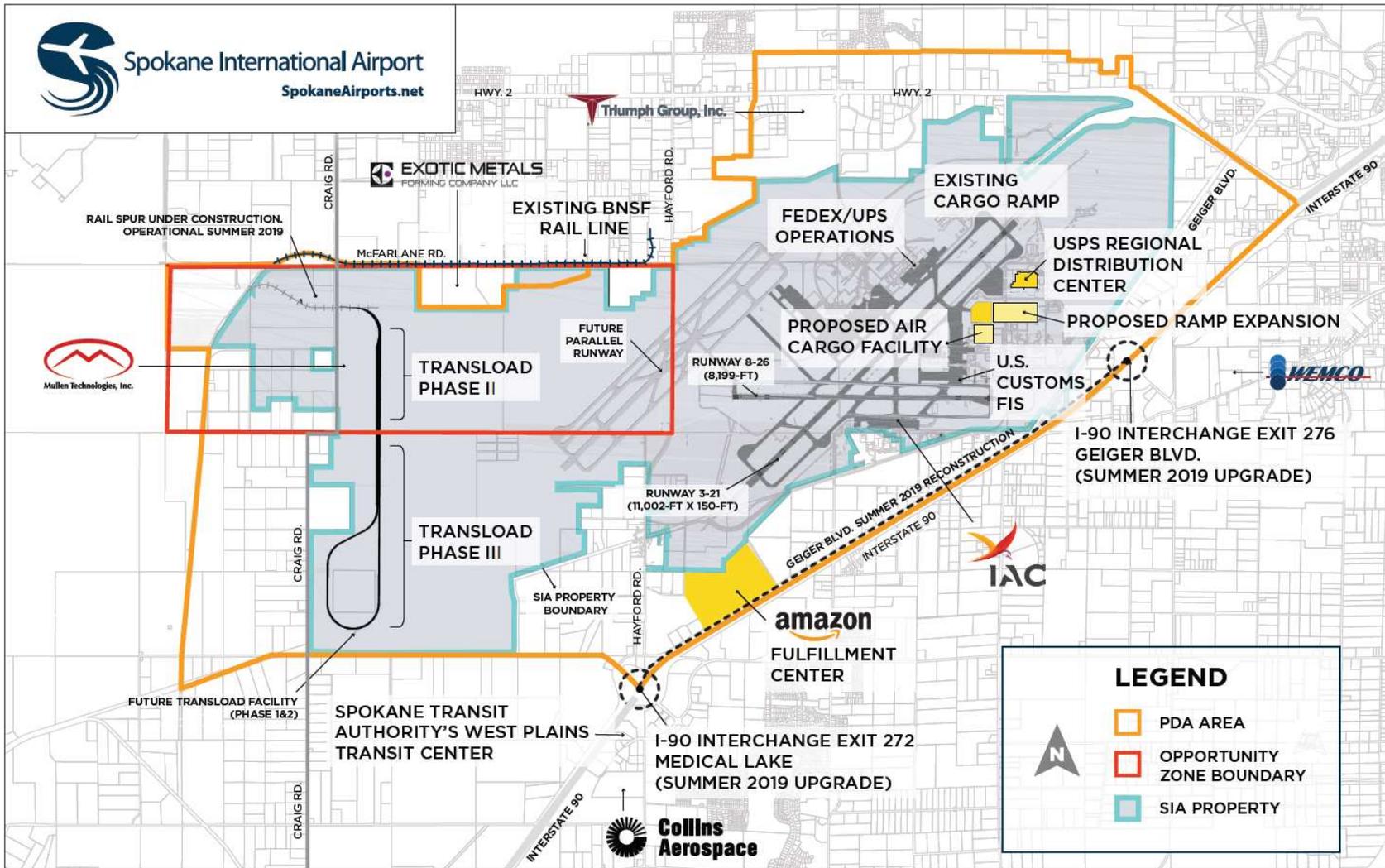

Phase I – Constructed in 2019

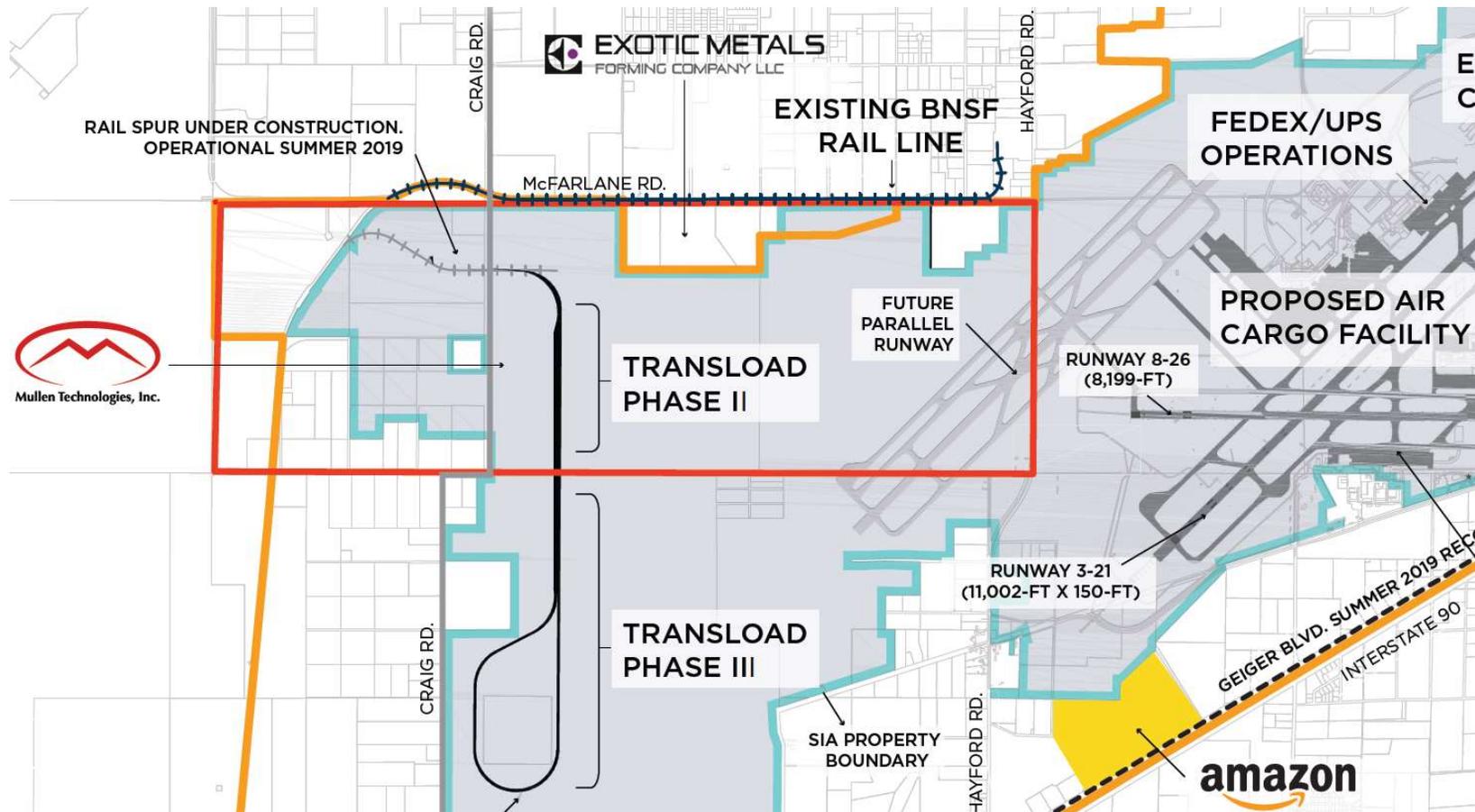

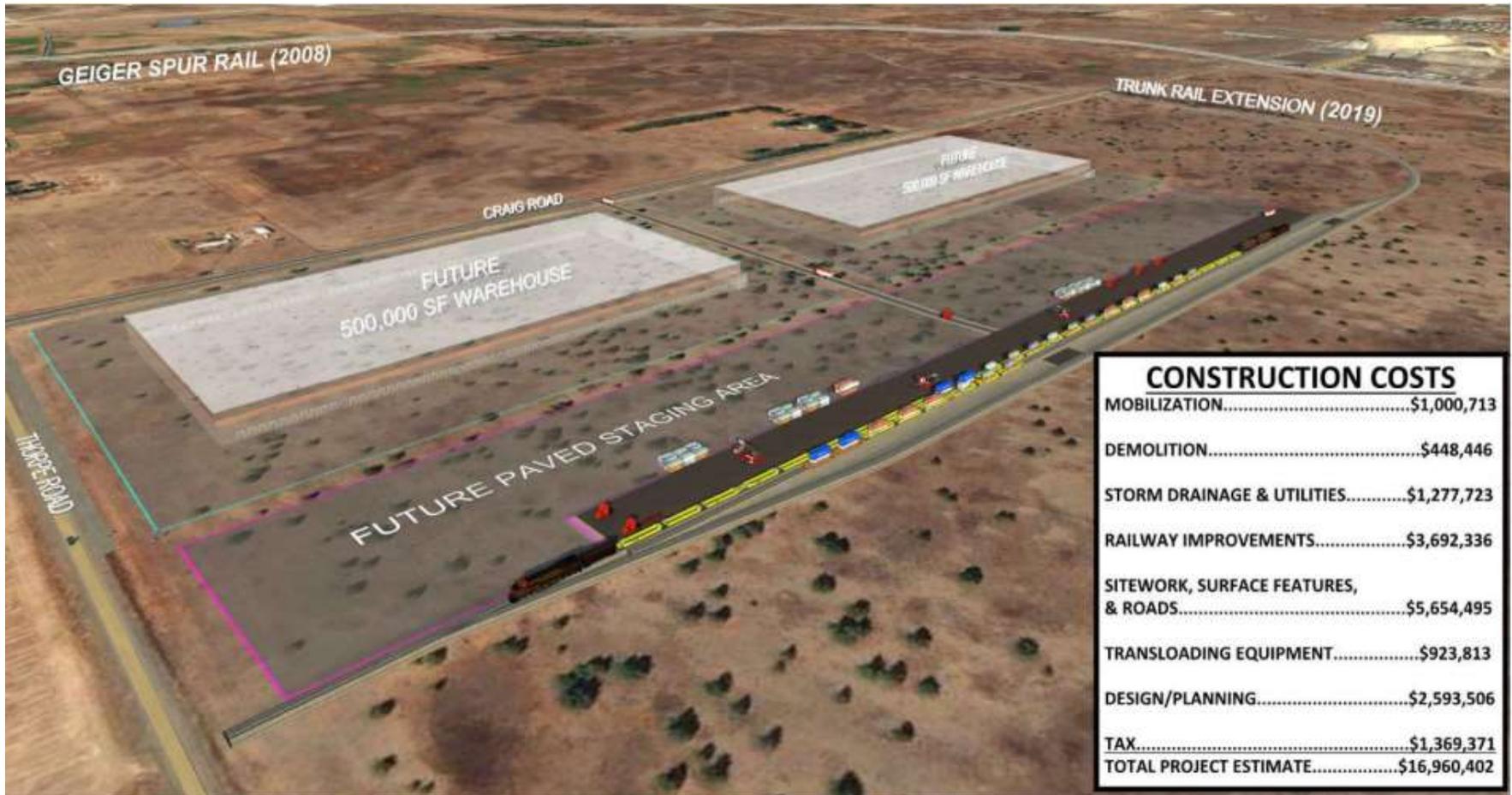
